



Parse Biosciences' 2026 Stem Cell and Developmental Biology Abstract Contest Official Rules

March 31, 2026

1. Eligibility Parse Biosciences' 2026 Stem Cell and Developmental Biology Abstract Contest (the "Contest") is open to legal residents of any location where Parse Biosciences ships its products and who are at least eighteen (18) years old at the time of entry, and at Parse's determination, has not within the prior two (2) years purchased any products from Parse. Employees of Parse Biosciences and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

2. Sponsor The Contest is sponsored by Parse Biosciences, Inc., located at 500 Dexter Ave. N. Suite 600, Seattle, WA 98109.

3. Agreement to Official Rules Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

4. Contest Period The Contest begins on April 15 at 8:00 AM Pacific Time and ends on May 4 at 11:59 PM Pacific Time (the "Contest Period"). Entries that are submitted before or after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest using the following methods:

How to Enter Eligible entrants can enter The Parse Biosciences' Abstract Contest by submitting an Abstract no greater than 500 words in length and relevant contact information via the online form provided at <https://resources.parsebiosciences.com/single-cell-grant-program-spring-2026-stem-cell-and-dev-bio> . Limit one (1) entry per person, per e-mail address for the duration of

the Contest Period. As a participant, your entry must fully meet all Contest requirements, as specified in the Official Rules, to be eligible to win a prize. Incomplete entries or those that do not adhere to the Official Rules or specifications will be disqualified at the Sponsor's sole discretion.

6. Abstract Judging On or about May 26, the Sponsor will select winners from among all eligible entries received. Abstracts will be judged by appointed Parse employees on introduction, research aim/objective, materials and methods, anticipated results, discussion, and significance and implications, and other criteria at Sponsor's sole discretion. Sponsor will attempt to notify the potential winner(s) via telephone or e-mail on or about May 26. If the potential Winner(s) cannot be contacted within 10 business days after the date of the first attempt to contact, the Sponsor may select an alternative potential Winner in his/her place from remaining non-winning, eligible entries.

7. Prizes The two (2) Winners of the Contest (each a "Winner") will receive their choice of one (1) Evercode™ Whole Transcriptome (WT), Evercode™ TCR, or Evercode™ BCR kit with corresponding Evercode™ Cell or Nuclei Fixation Kit, and approximately 2 B sequencing reads for whole transcriptome library for WT kit or 2 B reads for the whole transcriptome library and 0.5 B reads for a BCR or TCR sequencing library for BCR or TCR kit or the "Prize". Prize is subject to availability. There shall be no cash or other Prize substitution permitted except at the Sponsor's discretion. The Prize is non-transferable. The Winner(s), upon acceptance of the Prize, are solely responsible for all expenses related to the prize, including without limitation any and all local, state, and federal taxes. By accepting the Prize, the selected Winner(s) grant permission for the Sponsor to use the Winner's likeness, abstract, biographical information, and name for purposes of advertising and trade and further agree to participate in a follow-on marketing event where experience and general results from the use of the Prize will be communicated in a manner agreed upon between Sponsor and Winner(s) without further compensation unless prohibited by law. Any Prize awarded is subject to and governed exclusively by the Parse Commercial Terms. By entering the Contest and/or accepting or using any Prize, each Entrant and Winner agrees to be bound by the Parse Commercial Terms. In the event of any conflict between these Official Rules and the Parse Commercial Terms, the Parse Commercial Terms shall control with respect to the Prize and its use.

8. Disputes THIS CONTEST IS GOVERNED BY THE LAWS OF THE UNITED STATES AND THE STATE OF WASHINGTON, WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. The Entrant agrees, as a condition of participating in this promotion, that if any disputes cannot be resolved between the Entrant and the Sponsor, and if causes of action arise out of or are connected with this Contest, they shall be individually resolved exclusively before a court located in the state of Washington having

jurisdiction. Under no circumstances in any such dispute shall the participant be permitted to obtain awards for, and hereby waives all rights to, punitive, incidental, or consequential damages, including reasonable attorney's fees, other than participant's actual out-of-pocket expenses (i.e. costs associated with entering this Contest). The participant waives all rights to have damages multiplied or increased.
